The Grand Chapter of Florida, Order of the Eastern Star, Charitable Foundation, Inc. (Florida Eastern Star) has developed a program that permits funds to cover tuition for those accepted in an accredited college, university, community college or vocational institution within the State of Florida. This grant is available to Florida high school seniors, including home schooled students, graduating in 2024 (the "Florida Eastern Star Grant Program"). While grade point average is, of course, important, the primary focus of the Florida Eastern Star Grant Program is a student's desire for a career or vocation and a need for these funds.

Request for Proposal	Offer the Florida Eastern Star Tuition Grant Program to the students, who are legal residents of Florida and who will be graduating from the High School(s), including home schooled students, in all 67 Florida School Districts in 2024 and who will be thereafter attending an accredited university, college, junior college, community college or vocational institution within the State of Florida.

Program Available to:	Florida high school seniors graduating in 2024.
Funds to Pay for:	Tuition to an accredited university, college, junior college, community college or vocational institution within the State of Florida. It is a one-time grant for a one-year period. The amount of the award will be based on the amount available in the Fund. The awards will be divided between applicants who will attend college, junior college, community college and vocational school within the State of Florida. The money is issued for tuition ONLY and does not need to be repaid.
Deadline for Submission for Request for Award	January 1, 2024
Amount(s) to be Awarded	A total of \$30,000 to be divided among the particular awardees dependent upon the type of assistance payment.
When Paid	On tuition due date established by the university, college, junior college, community college or vocational institution.
To Whom Paid	The tuition award will be paid directly to the university, college, junior college, community college or vocational institution.
Requirements for Eligibility	<ul style="list-style-type: none"> <li>• Florida High School Senior graduating in 2024.</li> <li>• Acceptance to the university, college, junior college, community college or vocational institution of choice within the State of Florida.</li> <li>• Submission of a 5-paragraph essay on the subject of <b>“What does Freedom of Speech Mean to You?”</b></li> </ul>
How Will Notification of Award be Made?	The student and university, college, junior college, community college or vocational institution will each be notified in writing by The Grand Chapter of Florida Order of the Eastern Star, Charitable Foundation, Inc. The Worthy Grand Matron, or her designee, may present a Certificate to each student at the annual awards ceremony at their school. All funds will be sent directly to university, college, junior college, community college or vocational institution by the tuition due date.
